How long does a battery warranty last?

The standard warranty covers manufacturing defects and performance issues for a specified period,typically ranging from 24 to 72 months, depending on the battery model. To claim the warranty, the original purchase invoice and warranty card must be presented.

How do I know if my battery has a warranty?

For terms and conditions of pro-rata warranty, you can also check the warranty table given on the battery or on the website. Please refer to the application chart available at the respective purchase counters for recommended fitment.

What is a car battery warranty?

A car battery warranty is a guarantee provided by the battery manufacturer, covering defects in materials or workmanship for a specified period. Typically, it includes free replacement or repair of the battery if it fails to perform under normal usage conditions.

Can I get a new battery after a warranty period?

Some warranties offer a free replacement during the initial period and then switch to a pro-rata payment structure. This means you may receive partial credit toward a new battery after the initial period. Additionally, registration may be required to validate your warranty.

Are batteries covered by a warranty?

Batteries used in a commercial or professional application, such as taxis, driving instructors, emergency services, works vehicles, etc., are not covered by the full term of the warranty but instead come with a 6 month warranty. How does the guarantee work? The guarantee covers any manufacturing defects which arise within the guarantee period.

What should I do if a battery claims against the warranty?

In the event of a battery claim against the warranty the battery should be returned with proof of purchase to the original distributor or retailer for a visual inspection for damage and testing using suitable equipment. charge.
