How should a battery room be designed?

Battery rooms shall be designed with an adequate exhaust systemwhich provides for continuous ventilation of the battery room to prohibit the build-up of potentially explosive hydrogen gas. During normal operations, off gassing of the batteries is relatively small.

Does a battery room cover maintenance free or computer room type batteries?

Rubbish and waste produced should be removed regularly. Personal belongings of the workers should be kept in lockers instead of being scattered around the workplace.
