

Who are Northvolt's unsecured creditors?

UNSECURED CREDITORS Northvolt's unsecured creditors include its largest shareholders Goldman Sachs and Volkswagen(ETR: VOWG_p),whose brands Scania,Porsche and Audi are customers of the battery maker. Volta,a company which tests battery systems,is its largest creditor.

Is Northvolt on the brink of bankruptcy?

The company is now reportedly on the brink of bankruptcyCredit: Northvolt/Handout via REUTERS Europe's battery strategy is disintegrating,a prime exhibit of hubris and inflated rhetoric. Its flagship Northvolt gigafactory in northern Sweden has run out of money and is talking solemnly to creditors.

Could a UK battery maker be a 'British champion'?

Founded in 2019, the company had been billed as a potential British battery-making champion, securing investment from FTSE 100 companies Glencore and Ashtead and gaining a £100mn funding pledge from the government.

Who are britishvolt's biggest creditors?

Among Britishvolt's largest creditors was London-listed commodities trader Glencore,which was owed £26mn in loans and convertible notes. Two battery plant equipment suppliers -- Germany's DC Energy,which says on its website that it won a £100mn order from Britishvolt,and South Korea's Hana Technology -- are each owed more than £20mn.

Does Northvolt have a creditor?

China dominates the battery market, supplying the majority of the world's batteries and components. Notable omissions from Northvolt's list of creditors are many of the governments and public institutions which pledged funding to the company. Governments and public institutions have pledged the company more than EUR2.7bn over its lifetime.

Who owns Northvolt battery?

The Investment Management Corporation of Ontario (IMCO), Canada Pension Plan Investment Board (CPP Investments) and CDPQ have collectively invested around \$1.1bn into the battery maker, according to Reuters. Canadian public pension fund OMERS has also been a long-term backer of Northvolt.
