China s tariffs on imported solar panels

Will China levy a 50 percent tariff on solar panels?

Starting in January, imports of Chinese solar wafers and polysilicon will carry a 50 percent tariff, up from the current levy of 25 percent. Polysilicon is a type of silicon that is used to make solar panels, while wafers are the semiconductors used in the panels.

What if China imposes new solar tariffs on imports from Southeast Asia?

When the presidential moratorium on new solar tariffs on imports from Southeast Asia expires next June, imports of solar cells and modules from these five companies will be subject to the tariffs faced by Chinese solar manufacturers, with the tariff level ranging from 50 percent to 250 percent of the import value.

Did Trump impose tariffs on Chinese solar panels?

In early 2018,the Trump administration imposed 30% tariffs on imports of Chinese solar panels. Beijing filed a complaint with the World Trade Organization charging that the U.S. was unfairly supporting electric vehicle purchases.

Are EU tariffs affecting Chinese solar panels?

The European Union has had anti-dumping tariffs on imports of Chinese solar panels since 2014. In addition to the impact of tariffs in raising prices, changing supply chain trends are shifting towards local production.

Are Chinese companies skirting US tariffs on Chinese and Taiwanese solar panels?

Auxin Solar,a small California-based solar panel manufacturing company, petitioned the US government, arguing that Chinese companies are skirting US tariffson Chinese and Taiwanese solar cells and modules by effectively routing equipment through countries in Southeast Asia that are not subject to the same tariffs.

How will tungsten tariffs affect solar panels?

Tariffs on certain tungsten products will go from zero to 25 percent. Chinese companies produce more than 75 percent of the world's polysilicon. Considering all the manufacturing stages for solar panels, which includes polysilicon and wafers, China holds more than 80 percent of global capacity. American manufacturers welcomed the changes.

In 2013 the EC imposed tariffs of up to 64.9% on the original price of solar panels imported from China, after accusing Beijing of selling subsidised panels below cost in Europe. The tariffs were imposed to protect European solar panel manufacturers which at the time faced losing 25,000 jobs as a result of cheaper Chinese imports.

However, China has not always dominated the solar PV supply chain, and Europe had been the frontrunner in the "solar revolution". In 2007, 30 % of PV manufacturing was stilllocated in Europe.
