What is the customs declaration service?

The Customs Declaration Service allows you to manage your customs financial accounts and download statements. You can also give authority to others to use your accounts. You can use the Trader Dress Rehearsal service to practice submitting declarations, this is a free to use service.

Does the customs declaration service support import and export declarations?

The Customs Declaration Service supports making import and export declarations when moving goods into and out of the UK. All import declarations must now be made through the Customs Declaration Service. You can now start submitting all your export declarations through the Customs Declaration Service.

What is customs duty on solar panels?

According to TARIC, customs duty for photosensitive semiconductor devices, including photovoltaic cells whether or not assembled in modules or made up into panels; light-emitting diodes, code 8541409000, is 0%. In the HTS tariff system, the duty for solar cells assembled into modules or made up into panels (code 8541.40.60.15) is also 0%.

When do I need to declare goods through the customs declaration service?

All businesses will now need to declare goods through the Customs Declaration Service from 30 March 2024. Information added to 'About the Customs Declaration Service'. All businesses will need to declare goods through the Customs Declaration Service from 30 November 2023.

What is a completed customs declaration?

Completed customs declarations are often offered as part of the service by freight forwarders or courier companies. All the specifics and technicalities are taken care of and the cost is worked into the overall contract.

How do I make an import declaration?

To make an import declaration you need to choose how to pay duties, VAT or excise. The Customs Declaration Service allows you to manage your customs financial accounts and download statements. You can also give authority to others to use your accounts.

The Central Board of Indirect Taxes and Customs () has revoked the permission granted to solar developers to warehouse imported solar modules effective from December 17, 2024.CBIC ruled that goods imported for solar power generation will not be allowed to undergo any manufacturing processes or operations in a warehouse.

The Customs Department was of the view that solar modules are correctly classifiable under Heading 8501 as they feel that solar modules should be classified as a generator. This issue was finally resolved with the issuance of the instructions by the Central Board of Indirect Taxes and Customs (CBIC) on 06.04.2018.
