Do EV batteries qualify for Zero Tariffs?

These include provisions on rules of origin - the criteria for establishing that a product is of EU or UK origin and therefore qualifies for the preferential trade regime under the TCA. Why is the UK negotiating a tariff-free battery supply chain?

The agreement comes as both the Prime Minister and President of the EU commission committed to working together to bolster our domestic battery supply chain, showing that the Government is taking the lead on securing tariff-free access to global markets for electric vehicles manufactured in the UK and their batteries.

What if a battery does not meet EU requirements?

Vehicles and batteries that do not meet the requirements face a 10 % tariffat either the EU or the UK border. The rationale behind the rules was to incentivise investment in domestic battery manufacturing capacity.

Can a battery plant survive without exporting from the UK?

This means it will be able to meet some EU demandwithout exporting from the UK, and may be able to sustain its UK plant on domestic sales alone if it can secure the batteries, trade experts suggest.

Why did CBP decide on battery modules and packs?

CBP's decision on battery modules and packs confirms the importance of understanding the complexity of the substantial transformation rules.

Should UK batteries be required to have a battery passport?

The Government should empower UK consumers by requiring batteries available on the UK market to come with a battery passport containing information about how sustainably and ethically those batteries were produced.
