What is the tariff rate on lithium ion batteries?

In a Fact Sheet issued by the White House today (14 May),the Administration said it would increase the tariff rate on lithium-ion batteries for electric vehicles (EVs) from 7.5% to 25% in 2024,and the tariff rate for non-EV lithium-ion batteries from 7.5% to 25% in 2026.

What are China's new import taxes on lithium ion batteries?

This includes the removal of import taxes on lithium chloride, lithium carbonate, nickel sulphate, and cobalt carbonate, all previously set at 5%. Additionally, China eliminated the 3% import tax on low-arsenic fluorite, a crucial material for electrolyte production in lithium-ion batteries.

Why are China's import tariffs affecting the battery industry?

According to Ali Adim, senior analyst at S&P Global Mobility, & quot; The import tariffs aim to protect the North American battery supply chain from cheaper Chinese products, thereby levelling the playing field for the growing domestic industry.

When will EV battery tariffs take effect in China?

The Chinese Ministry of Finance announced on 21 December 2023 that the adjusted tariffs on selected metals, including aluminium and battery metals, would take effect from 1 January 2024. As part of its efforts to promote advanced manufacturing, China removed or reduced import taxes on key raw materials essential for EV battery production.
