

# How to test the battery power during the battery warranty

Only use the YUASA WARRANTY TEST option for testing batteries presented for a warranty claim, ensure that the appropriate battery type is selected (Regular Flooded or AGM Flat Plate) and an accurate Cold Cranking Amperag

What should I do if a battery claims against the warranty?

In the event of a battery claim against the warranty the battery should be returnedwith proof of purchase to the original distributor or retailer for a visual inspection for damage and testing using suitable equipment. charge.

What battery type should a battery tester be set to?

Set the battery tester to the correct battery type: Starter battery,gel battery,EFB or AGM battery. The device uses a different test algorithm for each battery type,so that an incorrect setting would produce an incorrect measurement value.

How do I test a battery?

Digital Testing - All Batteries Due to an increasing number of sealed, totally maintenance free batteries in the market place, acid specific gravity readings can not always be taken, therefore we recommend a test using a recognised digital conductance tester (Midtronics/Bosch BAT121). Battery terminals should be clean to ensure a meaningful result.

When should a car battery be tested?

A regular battery check by a specialist workshop is therefore advisable in order to detect an imminent battery failure before a final breakdown occurs. A measuring device which can only measure the state of charge of the battery is suitable to test a conventional car battery.
