How many eV and battery companies filed for bankruptcy?

Which EV maker has filed for bankruptcy?

The most high-profile EV maker bankruptcy in recent months has been Fisker, maker of the Ocean SUV. It filed for Chapter 11 bankruptcy in June 2024, after initial order levels for its debut production model fell short of internal expectations.

Did Northvolt go bankrupt?

Northvolt, a Swedish battery manufacturer and Europe's best-funded start-up, has filed for bankruptcy protection in the United States. The company attracted nearly \$15 billion in investments, secured over \$50 billion in battery orders, and was aiming for a \$20 billion public offering.

Why did Britishvolt go bankrupt?

Nick Carey/Reuters Britishvolt, a prominent battery start-up that generated enthusiasm from British politicians but never commercially produced a battery, filed for insolvency on Tuesday. The collapse deals a blow to Britain's ambitions to develop low-carbon businesses to replace some of the trade lost under Brexit.

Are EV startups going bankrupt?

While a big wave of EV startups have gone bankrupt in the years since the pandemic began, some didn't make it that far. Zhidou was one of China's earliest EV startups, being founded in 2006, and at one point it looked like it was destined for success.

Did Britishvolt kill the battery industry?

But the startup put the cart before the horse, beginning work long before firm demand materialized. A123 went bankrupt in 2012, and while its collapse was tragic, it didn't kill the U.S. battery sector. The same might not be true of Britishvolt.

The bankruptcy, the company's second in four years, was a result of declining foot traffic in malls and mismanagement that impacted sales. Brookstone hired liquidators to help close about 100 stores across the country. ...
