How does Tisi certification work in Thailand?

Thailand implements the TISI certification system that combines compulsory certification and voluntary certification. TISI mark is allowed for products that meet the standards For products that have not yet established standards, TISI also implements product registration as a temporary authentication method. Do I need a Tisi license to sell industrial products in Thailand?

Remark: TISI has specific energy efficiency requirements depending on the product. The manufacturers or importers who want to sell the industrial products in the Thai Market need to apply for a TISI license if such products are under TISI compulsory standards. The application requires factory inspection and testing.

Does Thailand have a mandatory certification body?

It is worth noting that Thailand does not have a non-governmental mandatory certification body. Thailand implements the TISI certification system that combines compulsory certification and voluntary certification.

How many products are required to be certified in Thailand?

Certification scope The Thai government requires that there be 60categories of products subject to compulsory certification, covering 8 areas, including: electrical equipment and accessories, medical equipment, building materials, consumer goods, vehicles, PVC pipes, LPG gas containers and agricultural products.

How to choose a lithium-ion battery in Thailand?

The lithium-ion battery must be certified by the Thailand Automotive Institute(TAI) or any other related institution and have a voltage of at least 48 volts. The battery should possess a minimum capacity of 3 kWh or offer a range of at least 75 km on a single charge.
